Review of Draft FY20 Audited Financial Statements	BAC received overview of the draft FY20 audited financial statements from ICANN org, including adoption of new accounting standards as well as COVID-19 disclosures in the financial statement footnotes.	16 October 2020	BAC received the comments and walked through the financial statements with ICANN org.
