Service Description

This service request should be used to submit a Registry Services Evaluation Policy (RSEP) request to implement the Bulk Transfer After Partial Portfolio Acquisition (BTAPPA) service, which permits Registry Operators to offer to registrars a bulk transfer service in the circumstance where (i) one ICANN-accredited registrar purchases, by means of a stock or asset purchase, merger or similar transaction, a portion but not all, of another ICANN-accredited registrar's domain name portfolio in the TLD or (ii) a newly accredited registrar (gaining registrar) requests a transfer of all domain names from the losing registrar for which the gaining registrar has served as the reseller.

The statements below reflect the standard implementation of the proposed service with no apparent significant security or stability issues as well as the standard amendment language for Bulk Transfer After Partial Portfolio Acquisition (BTAPPA). Registry Operator Confirmation

1. My registry requests to implement the Bulk Transfer After Partial Portfolio Acquisition (BTAPPA) service for the TLDs included in this request.

2. My registry confirms the amendment language below represents the proposed service in this RSEP request and my registry agrees to execute the Registry Agreement amendment without modification.

Note: amendment execution will occur once the request has successfully passed ICANN Review for security, stability, and competition.

Bulk Transfer After Partial Portfolio Acquisition

Bulk Transfer After Partial Portfolio Acquisition ("BTAPPA") is a registry service available to consenting registrars in the circumstance where:

- (i) one ICANN-accredited registrar purchases, by means of a stock or asset purchase, merger or similar transaction, a portion but not all, of another ICANN-accredited registrar's domain name portfolio in the TLD or
- (ii) a newly accredited registrar (gaining registrar) requests a transfer of all domain names from the losing registrar for which the gaining registrar has served as the reseller. Upon completion of the transfer, the gaining registrar is the new sponsoring registrar. The gaining registrar must certify the BTAPPA would not otherwise qualify under ICANN's Transfer Policy.

At least fifteen days before completing a BTAPPA, the losing registrar must provide written notice of the bulk change of sponsorship to all domain name registrants for names involved in the BTAPPA. The notice must include an explanation of how the RDDS record will change after the BTAPPA occurs and customer support and technical contact information of the gaining registrar.

The losing registrar's existing Registration Agreement with customers must permit the transfer of domain names in the event of acquisition by another party. A single BTAPPA request may be submitted for transfers from multiple losing registrars provided they are Affiliated Registrars as defined by the 2013 or subsequent Registrar Accreditation Agreement.

The expiration dates of transferred registrations are not affected and, therefore, there are no ICANN fees. Once the BTAPPA is complete, there is no grace period to reverse the transfer.

Domain names in the following EPP statuses at the time of the BTAPPA execution shall not be transferred:

- Base statuses: pendingTransfer, pendingDelete.
- Redemption Grace Period (“RGP”) statuses: redemptionPeriod, pendingRestore, pendingDelete.

Domain names that are within a grace period window are subject to BTAPPA, but Registry Operator may decline to provide a credit for those names deleted after the BTAPPA and prior to the expiration of the applicable grace period window.

Registry Operator must reject a BTAPPA request if there is reasonable evidence that a transfer under BTAPPA is being requested in order to avoid fees otherwise due to Registry Operator or ICANN. Registry Operator has discretion to reject a BTAPPA request if a registrar with common ownership or management or both has already requested BTAPPA service within the preceding six-month period.

Competition Questions

1. Do you believe the proposed service would have any positive or negative effects on competition? If so, please explain.

Positive. The service will facilitate operationally efficient execution of registrar M&A and portfolio restructuring transactions that would occur in any event, and supports registrar business models without changing pricing, access, or technical advantages at the registry level

2. How would you define the markets in which the proposed service would compete?

The market for registrar services to domain name registrants in the TLDs covered by this request and, more specifically, the subset of that market involving registrars that acquire or dispose of partial domain name portfolios.

3. What companies/entities provide services or products that are similar in substance or effect to the proposed service?

Other gTLD registry operators already offering BTAPPA or equivalent bulk transfer services, including Verisign for .com and .net and Identity Digital for certain gTLDs, provide services similar in substance and effect to the proposed BTAPPA service.

4. In view of your status as a Registry Operator, would the introduction of the proposed service potentially impair the ability of other companies/entities that provide similar products or services to compete?

The introduction of BTAPPA by our registry will not impair the ability of other registry operators or service providers to compete, because BTAPPA is a non-exclusive, optional service that any registry may request and implement on equivalent terms, and it does not restrict registrar or registrant choice.

5. Do you propose to work with a vendor or contractor to provide the proposed service? If so, what is the name of the vendor/contractor, and describe the nature of the services the vendor/contractor would provide.

Our RSP, CentralNic, will implement this service -- as they already do for other TLDs they service.

6. Have you communicated with any of the entities whose products or services might be affected by the introduction of the proposed service? If so, please describe the communications.

We have discussed BTAPPA in the ordinary course with registrars as part of broader registrar services and operations discussions, but we have not received any indications that the service would adversely affect their offerings. Feedback has been that BTAPPA is a useful facilitative tool for registrar transactions.

7. Do you have any documents that address the possible effects on competition of this proposed service? If so, please submit them with your application. ICANN will keep the documents confidential.
