

## **Amendment No. 2 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and Cam Connecting SARL agree, effective as of \_\_\_\_\_ (“Amendment No. 2 Effective Date”), that the modification set forth in this amendment No. 2 (the “Amendment”) is made to the 21 April 2016 .cam Registry Agreement between the parties, as amended (the “Agreement”).

The parties hereby agree to amend Exhibit A of the Agreement by deleting the following sections 3 and 4 in their entirety:

### **“3. Searchable Whois**

Notwithstanding anything else in this Agreement, Registry Operator must offer a searchable Whois service compliant with the requirements described in Section 1.10 of Specification 4 of this Agreement. Registry Operator must make available the services only to authenticated users after they logged in by supplying proper credentials (e.g., user name and password). Registry Operator must issue such credentials exclusively to eligible users and institutions that supply sufficient proof of their legitimate interest in this feature (e.g., law enforcement agencies).

### **4. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- 4.1.** Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- 4.2.** Registry Operator will not offer variant IDNs.
- 4.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - 4.3.1.** Albanian language

All capitalized terms not defined will have the meaning given to them in the Agreement. This Amendment may be executed in counterparts, each of which shall be deemed an original, and all of such counterparts taken together shall constitute one and the same instrument.
