# **Amendment to Registry Agreements**

NOW THEREFORE, the parties hereto, intending to be legally bound, hereby do agree to the following:
<ol> <li>The Registry Agreement for those TLDs identified in Appendix I shall be amended in the manner set forth in Appendix II.</li> </ol>
2. On the registry page for each individual TLD, the form of Amendment set forth in Appendix II shall be completed with the applicable information (e.g., Registry Operator Name, Registry Agreement Effective Date, TLD) and shall be posted in such form.
3. That, notwithstanding the lack of signature to any individual amendment to Registry Agreement for each TLD, the signature of the parties on this Amendment below shall bind the parties to the terms of amendment set forth in Appendix II for each Registry Agreement listed in Appendix I.
The parties agree that, except as set forth in this Amendment, the current terms and conditions of the applicable Registry Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Registry Agreement.

The parties hereby further agree to amend Exhibit A by replacing the deleted sections above with new text as new section 4.2 and section 4.3:

- **4.2.** Registry Operator must handle variant IDNs as follows:
  - **4.2.1.** Variant IDNs (as defined in the Registry Operator's IDN tables and IDN Registration Rules) will be blocked from registration.
- **4.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - 4.3.1. Cyrillic Script
  - 4.3.2. French Language
  - 4.3.3. Italian Language
  - 4.3.4. German Language
  - **4.3.5.** Portuguese Language

- **4.3.6.** Spanish Language
- 4.3.7. Chinese Language
- **4.3.8.** Japanese Language

The parties agree that, except as set forth in this Amendment, the current terms and conditions of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement.
