## Amendment No. 3 to Registry Agreement

set forth in this amendment No. 3 (the '	"Amendment") is made to the 22 December 2014 .dealer
Registry Agreement between the parties,	as amended (the "Agreement").

The parties hereby agree to amend Exhibit A of the Agreement by deleting the following sections 3 and 4 in their entirety:

#### **"3. Searchable Whois**

Notwithstanding anything else in this Agreement, Registry Operator must offer a searchable Whois service compliant with the requirements described in Section 1.10 of Specification 4 of this Agreement. Registry Operator must implement at least one of the following mechanisms in order to prevent abuse of the searchable Whois service:

- Username and password based authentication.
- Certificate based authentication.
- CAPTCHA (Completely Automated Public Turing test to tell Computers and Humans Apart) with rate-limiting mechanism to prevent repetitive invocation of the service.

## 4. Internationalized Domain Names (IDNs)

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- **4.1.** Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- **4.2.** Registry Operator must handle variant IDNs as follows:
  - **4.2.1.** Variant IDNs (as defined in the Registry Operator's IDN tables and IDN Registration Rules) will be blocked from registration.
- **4.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - **4.3.1.** Chinese Language
  - **4.3.2.** Cyrillic Script
  - **4.3.3.** French Language
  - **4.3.4.** German Language
  - **4.3.5.** Italian Language

- **4.3.6.** Japanese Language
- **4.3.7.** Portuguese Language
- **4.3.8.** Spanish language"

The parties hereby further agree to amend Exhibit A of the Agreement by replacing the deleted sections above with the following new text as a new section 3:

# **"3.** Internationalized Domain Names (IDNs)

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- **3.1.** Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- **3.2.** Registry Operator must handle variant IDNs as follows:
  - **3.2.1.** Variant IDNs (as defined in the Registry Operator's IDN tables and IDN Registration Rules) will be blocked from registration.
- **3.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - **3.3.1.** Chinese Language
  - 3.3.2. Cyrillic Script
  - **3.3.3.** French Language
  - **3.3.4.** German Language
  - 3.3.5. Italian Language
  - **3.3.6.** Japanese Language
  - **3.3.7.** Portuguese Language
  - 3.3.8. Spanish language"

All capitalized terms not defined will have the meaning given to them in the Agreement. This Amendment may be executed in counterparts, each of which shall be deemed an original, and all of such counterparts taken together shall constitute one and the same instrument.
