

Amendment No. 3 to Registry Agreement

The Internet Corporation for Assigned Names and Numbers and Dot Global Domain Registry Ltd agree, effective as of _____ (“Amendment No. 3 Effective Date”), that the modification set forth below is made to the 17 April 2014 **.GLOBAL** Registry Agreement between the parties (“Agreement”).
