

Amendment No. 1 to Registry Agreement

The Internet Corporation for Assigned Names and Numbers and Go Daddy East, LLC agree, effective as of _____ (“Amendment No. 1 Effective Date”), that the modification set forth below is made to the 23 July 2015 **.GODADDY** Registry Agreement between the parties (“Agreement”).

The parties hereby agree to amend Exhibit A by adding after the last section thereof entitled “2. Anti-Abuse” the following new text as a new section 3:

“3. Internationalized Domain Names (IDNs)

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- 3.1. Registry Operator must offer Registrars support for handling IDN registrations in EPP.

- 3.2. Registry Operator must handle variant IDNs as follows:
 - 3.2.1. By default variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) must be blocked from registration.
 - 3.2.2. Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules.
 - 3.2.3. Active variant IDNs must be provisioned in the TLD’s DNS zone file as zone cuts using the same NS resource records as the canonical name.

- 3.3. Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
 - 3.3.1. Arabic language
 - 3.3.2. Belarusian language
 - 3.3.3. Bosnian language
 - 3.3.4. Bulgarian language
 - 3.3.5. Chinese (Simplified) language
 - 3.3.6. Chinese (Traditional) language
 - 3.3.7. Danish language
 - 3.3.8. Finnish language
 - 3.3.9. French language
 - 3.3.10. German language
 - 3.3.11. Hindi language
 - 3.3.12. Hungarian language
 - 3.3.13. Icelandic language
 - 3.3.14. Italian language
 - 3.3.15. Korean language
 - 3.3.16. Latvian language
 - 3.3.17. Lithuanian language

- 3.3.18. Macedonian language
- 3.3.19. Montenegrin language
- 3.3.20. Polish language
- 3.3.21. Portuguese language
- 3.3.22. Russian language
- 3.3.23. Serbian language
- 3.3.24. Spanish language
- 3.3.25. Swedish language
- 3.3.26. Ukrainian language”

The parties agree that, except as set forth in this Amendment, the current terms and conditions of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement.
