

## **Amendment No. 1 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and Guccio Gucci S.p.a. agree, effective as of \_\_\_\_\_ (“Amendment No. 1 Effective Date”), that the modification set forth below is made to the 13 November 2014 **.GUCCI** Registry Agreement between the parties (“Agreement”).
