

## **Amendment No. 1 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and Wild Frostbite, LLC agree, effective as of \_\_\_\_\_ (“Amendment No. 1 Effective Date”), that the modification set forth below is made to the 9 January 2014 **.JETZT** Registry Agreement between the parties (“Agreement”).

The parties hereby agree to amend Exhibit A by deleting the following section in its entirety:

### **"4. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- 4.1** Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- 4.2** Registry Operator must handle variant IDNs as follows:
  - 4.2.1** By default variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) must be blocked from registration.
  - 4.2.2** Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules.
  - 4.2.3** Active variant IDNs must be provisioned in the TLD’s DNS zone file as zone cuts using the same NS resource records as the canonical name.
- 4.3** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - 4.3.1** German language”

The parties hereby further agree to amend Exhibit A by replacing the deleted section above with new text as a new section 4:

### **"4. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- 4.1** Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- 4.2** Registry Operator must handle variant IDNs as follows:
  - 4.2.1** Variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) will be blocked from registration.

**4.3** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):

**4.3.1** Chinese Language

**4.3.2** French Language

**4.3.3** German Language

**4.3.4** Spanish Language”

The parties agree that, except as set forth in this Amendment, the current terms and conditions of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement.
