

## Code of Conduct Exemption Request Form

RE: Request for Exemption from Registry Operator Code of Conduct

Bayerische Motoren Werke Aktiengesellschaft (“Registry Operator”), in connection with the execution of the Registry Agreement for the .MINI TLD (the “Registry Agreement”), hereby requests an exemption from the obligations of the Registry Operator Code of Conduct set forth in Specification 9 to the Registry Agreement (the “Code of Conduct”). Pursuant to such request, Registry Operator confirms that each of the following statements is true and correct (collectively, referred to as the “Statements”):

1. All domain name registrations in the TLD shall be registered to, and maintained by, Registry Operator for the exclusive use of Registry Operator or its Affiliates (as defined in the Registry Agreement);
2. Registry Operator shall not sell, distribute or transfer control or use of any registrations in the TLD to any third party that is not an Affiliate of Registry Operator; and
3. Application of the Code of Conduct to the TLD is not necessary to protect the public interest for the following reasons:

The TLD ultimately is intended to serve as BMW’s integrated online branding and services platform. It is envisaged to function with leading-edge technologies and business practices, ensuring a trustworthy and positive user experience. The goal is to use BMW’s online infrastructure, services and marketing to encourage Internet users to interact with the company online. BMW intends to use advanced technical and policy measures to ensure the security and reliability of online transactions and communications taking place on domains within the TLD, and to ensure that domain names in the TLD are only used for authorized purposes.

In general, BMW intends for users to perceive the TLD as a trustworthy and intuitive indicator of the source of its online information and services. BMW intends to use advanced technical and policy measures to ensure the security and reliability of online transactions and communications taking place on domains within the TLD, and to ensure that domain names in the TLD are only used for authorized purposes. Naturally, as BMW will be the registrant of all domain names within the space, it will have control over the content displayed on “.MINI” websites. BMW intends to provide a safe and trustworthy Internet space, enhancing user experience by mitigating security-associated risks.

The TLD is designed to reinforce the corporate ideals of BMW and its MINI brand, and to provide an online forum by which the company may communicate with all of its dealers, partners, affiliates, customers, investors and the general public in a streamlined and consistent manner. Domains within the TLD will only be used for purposes authorized by BMW, and domain usage guidelines will be implemented and enforced to constantly ensure the integrity and reputation of the TLD. Domain usage guidelines will be implemented and enforced to constantly ensure the integrity of users' ".MINI" experience and the reputation of the TLD.

All domain name registrations within the ".MINI" space shall be held by BMW. The company may, from time to time and in its sole discretion, elect to license domain name registrations to appropriate corporate divisions, subsidiaries, affiliated and authorized importers and dealers, and other affiliated entities, in order to further the business interests of the company. All domain name registrations and license agreements shall incorporate the usage requirements set out in the Domain Name Registration and Use Policy for ".MINI," a draft version of which is provided at the end of this section. BMW intends that no domain name in the ".MINI" space shall be used in a manner which:

- infringes any other third parties rights
- is in breach with any applicable laws, government rules or requirements

or for the purposes of:

- undertaking any illegal or fraudulent actions, including spam or phishing activities, or
- defaming BMW or its businesses, affiliates, dealers, employees, etc.

The ".MINI" domain space shall be used for the benefit of the BMW company. BMW will have the right to revoke any domain name license agreement should BMW deem such action appropriate for the benefit of BMW and its business interests.

The content and use of all registered ".MINI" domain names will be monitored by BMW on an ongoing basis, and compliance with the contractual restrictions and guidelines will be enforced. Violations of any restrictions, guidelines or other contractual conditions may result in termination of the relevant domain name license.

Registry Operator represents that the registration policies attached hereto as Exhibit A are a true and correct copy of the Registry Operator's registration policies for the TLD. Registry Operator agrees that if Registry Operator makes any changes to its registration policies (whether before or after an exemption has been granted), it will promptly provide ICANN with a revised set of registration policies.

Registry Operator acknowledges and agrees that in the event that any of the foregoing Statements becomes untrue (including after ICANN has granted an exemption pursuant to this exemption request), any Code of Conduct exemption granted by ICANN to Registry Operator for the TLD shall immediately expire, and Registry Operator shall (i) immediately notify ICANN specifying in reasonable detail the circumstances causing any of the Statements to be untrue and (ii) immediately comply with the Code of Conduct.

Registry Operator further acknowledges and agrees that ICANN may revoke this exemption at any time based upon evidence reasonably satisfactory to ICANN that the Statements have become untrue. In the event that ICANN provides notice that it has revoked this exemption, Registry Operator shall immediately comply with the Code of Conduct.

## EXHIBIT A

### Domain Name Registration and Use Policy for “.MINI”

#### I. General principles

##### 1. Purpose

The “.MINI” Top Level Domain (“TLD”) established by and for the use of Bayerische Motoren Werke Aktiengesellschaft (BMW), the Registry Operator for the TLD space. The Registry Operator reserves the sole and exclusive right to make any changes to domain name registrations within the .MINI (including the cancellation, transfer, deletion or suspension of any such domains) where it determines that the registration in question is in violations of the terms and conditions contained herein, or is contrary to the best interests of BMW.

This Policy is intended to be updated and revised regularly to reflect the needs of BMW and its TLD. The current version of this Policy will be made publicly available at: [insert website when determined].

The registration of domain names within the “.MINI” TLD shall be restricted to BMW itself, thus following a single-registrant model. BMW may, from time to time and in its sole discretion, elect to license domain name registrations to appropriate corporate divisions, subsidiaries, affiliated and authorized importers and dealers, and other affiliated entities.

##### 2. Registration Policy

As indicated above, the “.MINI” follows a single-registrant model. Thus, Bayerische Motoren Werke Aktiengesellschaft shall be the only entity eligible to register domain names within the “.MINI” TLD.

##### 3. Licensing of domain name registrations

Bayerische Motoren Werke Aktiengesellschaft may, in its sole discretion, elect to license domain name registrations within the “.MINI” space to, inter alia, appropriate corporate divisions, subsidiaries, and other affiliated entities. In all cases, however, BMW will remain the registrant of record for all domain name registrations within the TLD, and shall retain the authority to modify or terminate such registrations at any time via the concerned registrar.

#### II. Domain Allocation Rules

##### 3. String Requirements and Reserved Names

###### String Requirements

Second-Level Domain names within the TLD must only include hyphens in the third and fourth position if they represent valid internationalized domain names in their ASCII encoding (for

example “xn--ndk061n”), and must otherwise comply with any other applicable ICANN requirements.

## Reserved Names

At all times Bayerische Motoren Werke Aktiengesellschaft will reserve names from registration in accordance with Specification 5 of the Registry Agreement.

However, BMW may propose the release of these reservations, subject to review by ICANN’s Governmental Advisory Committee and approval by ICANN.

## III. Acceptable Usage Guidelines for “.MINI” Domain Names

### 6. Acceptable Use

The “.MINI” space is intended to function as the BMW’s online corporate branding platform, and as such the registrations therein should generally support the goals and mission of the organization.

Accordingly, no registered .MINI domain name may be used in a manner which:

- infringes any other third parties rights
- is in breach with any applicable laws, government rules or requirements

or for the purposes of:

- undertaking any illegal or fraudulent actions, including spam or phishing activities, or
- defaming BMW or its businesses, affiliates, dealers, employees, etc.

BMW will monitor the use of all domain names registered in the “.MINI” space to ensure that the content displayed thereon is in the best interests of the company and its business endeavors. Failure to comply with the terms and conditions set out in this Registration agreement will result in the immediate cancellation, transfer, deletion or suspension of a registered .MINI domain. The Registry Operator reserves the right to make any necessary changes to a domain name registration in the event of breach of the provisions herein established.

## IV. Dispute Resolution Policies

The registrant of any .MINI domain name hereby agrees to be bound to the provisions of the following dispute resolution Policies in force within the .MINI space:

### 7. Uniform Domain Name Dispute Resolution Policy (“UDRP”)

The Uniform Domain Name Dispute Resolution Policy (“UDRP”) shall apply to any challenges to registered domain names on the grounds that: 1) such domain names are identical or confusingly similar to a trademark in which the complainant has rights, 2) the registrant lacks

rights or legitimate interests in the domain name, and 3) the domain name has been registered and used in bad faith.. The full text of the UDRP is located at the following address:

#### 8. Uniform Rapid Suspension System (“URS”)

The Uniform Rapid Suspension System (“URS”) shall apply to any challenges to registered domain names on the grounds that: 1) such domain names are identical or confusingly similar to a trademark in which the complainant has rights, 2) the registrant lacks rights or legitimate interests in the domain name, and 3) the domain name has been registered and used in bad faith. #### 9. Trademark Post-Delegation Dispute Resolution Procedure (Trademark PDDRP)

The Registry Operator for “.MINI” shall agree to be bound by the Trademark Post-Delegation Dispute Resolution Procedure (Trademark PDDRP). The Trademark PDDRP applies to challenges by trademark holders claiming that one or more of its marks have been infringed, and thereby the trademark holder has been harmed, by the registry operator’s manner of operation or use of the gTLD. 10. The Registry Operator for “.MINI” will comply with all dispute resolution mechanisms as defined in the registry agreement Specification 7 article 2, and as revised from time to time by ICANN consensus policies and procedures. Registrant of .MINI domain names agrees to be bound by all applicable domain name dispute policies, as outlined in this Registration Agreement.

These dispute mechanisms include, but are not limited to:

- the Trademark Post-Delegation Dispute Resolution Procedure (“PDDRP”);
- the Uniform Rapid Suspension system (“URS”);
- the Public Interest Commitment Dispute Resolution Procedure (PICDRP);
- the Uniform Domain Name Dispute Resolution Policy (“UDRP”).
