

Amendment No. 1 to Registry Agreement

The Internet Corporation for Assigned Names and Numbers and Shell Information Technology International Inc agree, effective as of _____ (“Amendment No. 1 Effective Date”), that the modification set forth in this amendment No. 1 (the “Amendment”) is made to the 30 July 2015 .shell Registry Agreement between the parties, as amended (the “Agreement”).

The parties hereby agree to amend Exhibit A of the Agreement by deleting the following section 5 in its entirety:

“5. Internationalized Domain Names (IDNs)

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

5.1. Registry Operator must offer Registrars support for handling IDN registrations in EPP.

5.2. Registry Operator must handle variant IDNs as follows:

5.2.1. Variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) will be blocked from registration.
