

### **Amendment No. 3 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and Top Level Design, LLC agree, effective as of \_\_\_\_\_ (“Amendment No. 3 Effective Date”), that the modification set forth below is made to the 07 November 2013 **.WIKI** Registry Agreement between the parties (“Agreement”), as amended by Amendment No. 2 dated 10 July 2014.

The parties hereby agree to amend Exhibit A by deleting the following sections in their entirety:

“**2.2.** Registry Operator must handle variant IDNs as follows:

**2.2.1.** Variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) will be blocked from registration.

**2.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):

**2.3.1.** Arabic language

**2.3.2.** Cyrillic script

**2.3.3.** Greek script

**2.3.4.** Hebrew language

**2.3.5.** Japanese language

**2.3.6.** Korean language

**2.3.7.** Lao language

**2.3.8.** Latin script

**2.3.9.** Thai language”

The parties hereby further agree to amend Exhibit A by replacing the deleted sections above with new text as a new sections 2.2 and 2.3:

”**2.2.** Registry Operator must handle variant IDNs as follows:

**2.2.1.** By default variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) must be blocked from registration.

**2.2.2.** Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules.

**2.2.3.** Active variant IDNs must be provisioned in the TLD’s DNS zone file as zone cuts using the same NS resource records as the canonical name.

**2.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):

**2.3.1.** Arabic language

**2.3.2.** Chinese language

**2.3.3.** Cyrillic script

**2.3.4.** Greek script

**2.3.5.** Hebrew language

**2.3.6.** Japanese language

**2.3.7.** Korean language

**2.3.8.** Lao language

**2.3.9.** Latin script

**2.3.10.** Thai language”

The parties agree that, except as set forth in Amendment No. 2 and this Amendment No. 3, the current terms and conditions of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement, as amended.
