Termination of Registry Agreement for Volkswagen (China) Investment Co., Ltd.

Dear ICANN,

Pursuant to Section 4.4(b) of the ICANN Registry Agreement (RA) between ICANN and Volkswagen (China) Investment Co., Ltd., this letter hereby requests the termination of the RA for .大众汽车.

Volkswagen (China) Investment Co., Ltd. understands that the Termination Effective Date will be 180 days from the date of receipt of this notification.


Further, Volkswagen (China) Investment Co., Ltd. respectfully requests that ICANN not transition the .大众汽车 TLD to a third party and that ICANN does not delegate .大众汽车 to a successor registry operator for a period of two years following the termination date pursuant to Section 4.5 and Specification 13, Section 6 of the .大众汽车 Registry Agreement, respectively, given the following:

- The only domain name registered in .大众汽车, nic.大众汽车, is registered to and maintained by Volkswagen (China) Investment Co., Ltd., the Registry Operator, for its exclusive use;
- Volkswagen (China) Investment Co., Ltd. in its function as the Registry Operator, does not sell, distribute, or transfer control or use of any registrations in the .大众汽车 TLD to any third parties that is not an Affiliate of Registry Operator; and
- Transitioning operation of the .大众汽车 TLD is not necessary to protect the public interest.

We kindly ask ICANN to initiate the termination process as soon as possible. Please let us know if you require any further information.
