

Assignment and Assumption of .八卦(xn--45q11c) Registry Agreement

This Assignment and Assumption of .八卦(xn--45q11c) Registry Agreement (this “**Agreement**”) is made and entered into on 10 December, 2014(the “**Effective Date**”) by and between the following parties:

1. Zodiac Scorpio Limited, a company organized and existing under the laws of Hong Kong (Company Number: 1675360), with a registered address of Room C, 21/F., Central 88, 88 Des Voeux Road, Central, Hong Kong(“**Zodiac Scorpio**”); and
2. Zodiac Gemini Ltd, a company organized and existing under the laws of the British Virgin Islands (Company Number: 1829294), with a registered address of Start Chambers, Wickham’s Cay II, P.O. Box 2221, Road Town, Tortola, British Virgin Islands (“**Zodiac Gemini**”).

Zodiac Scorpio and Zodiac Gemini are each referred to herein as a “**Party**” and collectively as the “**Parties**”.

BACKGROUND

- A. Zodiac Scorpio is a party to the .八卦 (xn--45q11c) Registry Agreement between Zodiac Scorpio and Internet Corporation for Assigned Names and Numbers (“ICANN”) entered into on or about 21 November 2013(the “**Registry Agreement**”).
- B. Zodiac Scorpio and Zodiac Gemini are wholly-owned subsidiaries of Zodiac Registry Limited, a company organized and existing under the laws of the Cayman Islands (CR Number: CF-271056), with a registered address of P.O. Box 613, 4th Floor Harbour Centre, George Town, Grand Cayman KY1-1107, Cayman Islands.
- C. Zodiac Scorpio desires to assign the Registry Agreement to Zodiac Gemini and Zodiac Gemini desires to assume the Registry Agreement, pursuant to the terms and conditions of this Agreement.

AGREED TERMS

In consideration of the promises and covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Zodiac Scorpio hereby assigns and transfers to Zodiac Gemini all of Zodiac Scorpio’s rights, title and interest in and to the Registry Agreement.
2. Zodiac Gemini hereby accepts the assignment of the Registry Agreement, assumes all Zodiac Scorpio’s liabilities under the Registry Agreement and agrees to perform all of Zodiac Scorpio’s obligations under the Registry Agreement.
3. The Parties hereby agree that Zodiac Gemini shall be substituted for Zodiac Scorpio for all purposes of the Registry Agreement as of the Effective Date.

4. Each Party must promptly do whatever the other Party reasonably requires of it to perfect Zodiac Scorpio's assignment of the Registry Agreement to Zodiac Gemini pursuant to this Agreement.
5. This Agreement shall be governed by the laws of Hong Kong.
