

## Assignment and Assumption of .商城(xn--czru2d) Registry Agreement

This Assignment and Assumption of .商城(xn--czru2d) Registry Agreement (this “**Agreement**”) is made and entered into on May 28, 2014(the “**Effective Date**”) by and between the following parties:

1. Zodiac Capricorn Limited, a company organized and existing under the laws of Hong Kong, with a registered address of Flat 2, 19/F, Henan Building, 90-92 Jaffe Road, Wanchai,Hong Kong(“**Zodiac Capricorn**”); and
2. Zodiac Aquarius Ltd, a company organized and existing under the laws of the British Virgin Islands (Company Number: 1816012), with a registered address of Start Chambers, Wickham’s Cay II, P.O. Box 2221, Road Town, Tortola, British Virgin Islands (“**Zodiac Aquarius**”).

Zodiac Capricorn and Zodiac Aquarius are each referred to herein as a “**Party**” and collectively as the “**Parties**”.

### BACKGROUND

- A. Zodiac Capricorn is a party to the .商城(xn--czru2d) Registry Agreement between Zodiac Capricorn and Internet Corporation for Assigned Names and Numbers (“**ICANN**”) entered into on or about 21 November 2013(the “**Registry Agreement**”).
- B. Zodiac Capricorn and Zodiac Aquarius are wholly-owned subsidiaries of Zodiac Registry Limited, a company organized and existing under the laws of the Cayman Islands (CR Number: CF-271056), with a registered address of P.O. Box 613, 4th Floor Harbour Centre, George Town, Grand Cayman KY1-1107, Cayman Islands.
- C. Zodiac Capricorn desires to assign the Registry Agreement to Zodiac Aquarius and Zodiac Aquarius desires to assume the Registry Agreement, pursuant to the terms and conditions of this Agreement.

### AGREED TERMS

In consideration of the promises and covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Zodiac Capricorn hereby assigns and transfers to Zodiac Aquarius all of Zodiac Capricorn’s rights, title and interest in and to the Registry Agreement.
2. Zodiac Aquarius hereby accepts the assignment of the Registry Agreement, assumes all Zodiac Capricorn’s liabilities under the Registry Agreement and agrees to perform all of Zodiac Capricorn’s obligations under the Registry Agreement.
3. The Parties hereby agree that Zodiac Aquarius shall be substituted for Zodiac Capricorn for all purposes of the Registry Agreement as of the Effective Date.

4. Each Party must promptly do whatever the other Party reasonably requires of it to perfect Zodiac Capricorn's assignment of the Registry Agreement to Zodiac Aquarius pursuant to this Agreement.
5. This Agreement shall be governed by the laws of Hong Kong.
