

Assignment and Assumption of .网店(xn--hxt814e) Registry Agreement

This Assignment and Assumption of .网店(xn--hxt814e) Registry Agreement (this “**Agreement**”) is made and entered into on 4 August, 2014 (the “**Effective Date**”) by and between the following parties:

1. Zodiac Libra Limited, a company organized and existing under the laws of Hong Kong, with a registered address of Room C, 21/F., CMA Building, No. 64 Connaught Road, Central, Hong Kong (“**Zodiac Libra**”); and
2. Zodiac Taurus Limited, a company organized and existing under the laws of the British Virgin Islands (Company Number: 1829293), with a registered address of Start Chambers, Wickham’s Cay II, P.O. Box 2221, Road Town, Tortola, British Virgin Islands (“**Zodiac Taurus**”).

Zodiac Libra and Zodiac Taurus are each referred to herein as a “**Party**” and collectively as the “**Parties**”.

BACKGROUND

- A. Zodiac Libra is a party to the .网店 (xn--hxt814e) Registry Agreement between Zodiac Libra and Internet Corporation for Assigned Names and Numbers (“ICANN”) entered into on or about 15 May 2014 (the “**Registry Agreement**”).
- B. Zodiac Libra and Zodiac Taurus are wholly-owned subsidiaries of Zodiac Registry Limited, a company organized and existing under the laws of the Cayman Islands (CR Number: CF-271056), with a registered address of P.O. Box 613, 4th Floor Harbour Centre, George Town, Grand Cayman KY1-1107, Cayman Islands.
- C. Zodiac Libra desires to assign the Registry Agreement to Zodiac Taurus and Zodiac Taurus desires to assume the Registry Agreement, pursuant to the terms and conditions of this Agreement.

AGREED TERMS



In consideration of the promises and covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Zodiac Libra hereby assigns and transfers to Zodiac Taurus all of Zodiac Libra’s rights, title and interest in and to the Registry Agreement.
2. Zodiac Taurus hereby accepts the assignment of the Registry Agreement, assumes all Zodiac Libra’s liabilities under the Registry Agreement and agrees to perform all of Zodiac Libra’s obligations under the Registry Agreement.
3. The Parties hereby agree that Zodiac Taurus shall be substituted for Zodiac Libra for all purposes of the Registry Agreement as of the Effective Date.

4. Each Party must promptly do whatever the other Party reasonably requires of it to perfect Zodiac Libra's assignment of the Registry Agreement to Zodiac Taurus pursuant to this Agreement.
5. This Agreement shall be governed by the laws of Hong Kong.
