Re: Notice of Termination the Registry Agreement for .xn--mgbt3dhd

Dear Seyed Mohammad Emaminejad,

This letter constitutes written notice that ICANN is terminating the .xn--mgbt3dhd Registry Agreement entered into between ICANN and Asia Green IT System Bilgisayar San. ve Tic. Ltd. Sti. (AGIT) on 4 September 2014 (.xn--mgbt3dhd Registry Agreement).

Specifically, ICANN is invoking certain provisions set forth in the previously agreed-upon confidential terms reflected in a term sheet dated 25 October 2024 (Term Sheet) between ICANN and AGIT, as the Registry Operator for the .xn--mgbt3dhd generic top-level domain (gTLD).

On 1 July 2024, AGIT was issued a [Notice of Breach](#) by ICANN Contractual Compliance. Subsequently, and pursuant to Section 4.3(a) of the .xn--mgbt3dhd Registry Agreement, ICANN initiated termination proceedings by serving a Notice of Mediation under Section 5.1 of the .xn--mgbt3dhd Registry Agreement (see updates on ICANN's Notices of Breach, Suspension, Termination and Non-Renewal page [here](#)). The mediation resulted, in part, in AGIT agreeing to certain confidential terms reflected in the Term Sheet.

AGIT currently is in breach of certain of its obligations set forth in the Term Sheet. Accordingly, and pursuant to the terms set forth in the Term Sheet, ICANN is hereby giving fifteen (15) days written notice to AGIT of termination of the .xn--mgbt3dhd Registry Agreement, termination effective on 21 December 2024.

Pursuant to Section 4.5 of the .xn--mgbt3dhd Registry Agreement, following termination of the .xn--mgbt3dhd Registry Agreement, ICANN will conduct an assessment and make its determination whether to transition operation of the .xn--mgbt3dhd gTLD to a successor registry operator.

You should be aware of the following related to the termination of the .xn--mgbt3dhd Registry Agreement:
