

## **Amendment No. 3 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and ICM Registry, LLC agree, effective as of \_\_\_\_\_ (“Amendment No. 3 Effective Date”), that the modifications set forth below are made to the 30 March 2011 .xxx Registry Agreement (“Agreement”).

The Parties agree to the following modifications to Appendix 6:

**A. Deleting Old Text:**

- **Tagged Domain Names.** All labels with hyphens in the third and fourth character positions (e.g., "bq--1k2n4h4b" or "xn--ndk061n")

**B. Replacing with Next Text:**

- **Tagged Domain Names.** All DNS labels with hyphens in the third and fourth character positions (e.g., "bq--1k2n4h4b"), with the exception of DNS labels that represent valid IDNs in their ASCII encoding (e.g., "xn--ndk061n").

The Parties further agree to the following modifications to Attachment 1 of Appendix S:

**A. Deleting** the Multi-Lingual Domain Registration Service section in its entirety.

**B. Adding** new section at the end of the Product List to read as follows:

### **Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- I. Comply with RFCs 5890, 5891, 5892, 5893 and their successors. Registry Operator shall comply with the ICANN IDN Guidelines at <http://www.icann.org/en/topics/idn/implementation-guidelines.htm>, as they may be amended, modified, or superseded from time to time. Registry Operator shall publish and keep updated its IDN Tables and IDN Registration Rules in the IANA Repository of IDN Practices as specified in the ICANN IDN Guidelines.
- II. Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- III. Registry Operator must handle variant IDNs as follows:
  - i. By default variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) must be blocked from registration.
  - ii. Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules.

- iii. Active variant IDNs must be provisioned in the TLD's DNS zone file as zone cuts using the same NS resource records as the canonical name.
- IV. Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
- i. Arabic language
  - ii. Belarusian language
  - iii. Bosnian language
  - iv. Bulgarian language
  - v. Chinese (Simplified) language
  - vi. Chinese (Traditional) language
  - vii. Danish language
  - viii. French language
  - ix. German language
  - x. Hungarian language
  - xi. Icelandic language
  - xii. Italian language
  - xiii. Korean language
  - xiv. Latvian language
  - xv. Lithuanian language
  - xvi. Macedonian language
  - xvii. Montenegrin language
  - xviii. Polish language
  - xix. Portuguese language
  - xx. Russian language
  - xxi. Serbian language
  - xxii. Spanish language
  - xxiii. Swedish language
  - xxiv. Ukrainian language

The parties agree that, except as set forth in this Amendment, the current terms of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement.
